LCEC's Qualification Process

The process of qualification for Energy Service Companies in Lebanon is part of Lebanon's National Energy Efficiency Action Plan.

It aims at supporting the market, promoting investments in energy-efficiency services and helping stakeholders (potential beneficiaries and local financial institutions) identify the companies providing such services.

All listed companies are specialized in energyefficiency improvement services and set as legally independent entities even when they are part of larger groups providing other services.

The qualification process is active all year long - companies can submit an application any time during the year. However, the LCEC evaluation committee will gather a definite number of times per year to assess the recently submitted applications. The next evaluation will be set in July 2018.
